

# Information for individuals on the processing of personal data by the data controller BSL d.o.o.

---

## I. Presentation of BSL d.o.o.

The company BSL d.o.o., Beethovnova ulica 14, 1000 Ljubljana, is the owner and manager of the Parking House Šubičeva ulica 3A, Ljubljana (hereinafter PH). BSL d.o.o. is a great supporter to new technological solutions and is convinced that they are important for the quality of the service and are also fully complementary with the right of individuals to the protection of personal data.

*»We respect the privacy of our employees, partners and customers, and we always process their personal data to the minimum extent possible, that still allows us to achieve our business goals.«*

## II. The purpose of the processing of personal data and the legal basis

The company is the controller according to the General Data Protection Regulation (EU Regulation 2016/679) and ZVOP-1 regarding data on its employees, contractual partners, as well as information about users and visitors of the PH. The data controller process the personal data for the purposes and within the frameworks necessary for the implementation of contracts (on employment, on the implementation of various services or contracts for renting a parking space in the PH) - pursuant to Article 6/1, point b of the General Data Protection Regulation.

Where a company is liable for the processing of personal data for the purpose of fulfilling a legal obligation (Article 6 / I, point c of the General Regulation), personal data may be transmitted on the basis or in the frame of legal basis and under other international treaties, EU regulations and national laws, to the state bodies (such as the Ministry of the Interior, the Tax Office, various inspections, etc.) and other data controllers (such as the ZZSZ, ZRSZ, ZPIZ ...).

BSL d.o.o. relies to the legitimate interest referred to in Article 6 (I) of point f of the General Data Protection Regulation regarding the processing of personal data for the purpose of reducing the risks of intrusion on its web site (providing information security, minimizing the risks of unauthorized access to important business information, personal data and information systems) and processing personal data for internal analytical and statistical purposes.

Video surveillance carried out by the operator in the PH is in line with the provisions of the ZVOP-1 (Articles 74 to 77) and is intended to control the entry and exit of the PH, the protection of people and employees whose nature of work is such that there is a potential for threatening of employees by users of the PH, prevention of damage and protection of the property of BSL d.o.o. and order maintenance.

BSL d.o.o. does not transfer personal data to third countries, processors of personal data who, in addition to the employees, process personal data, and are carefully selected and are all established in the Member States of the European Union.

## III. Rights of individuals

An individual can in written letter sent to BSL d.o.o., Beethovnova ulica 14, 1000 Ljubljana or sent to e-mail address [pisarna@parkirnahisa.si](mailto:pisarna@parkirnahisa.si), request **access, supplement, correction, blocking or limitation of processing or deletion of personal data, and object to the processing of data** processed in connection with it and require **data transmission**.

Where the processing of personal data is based on the consent, the individual may, at any time, permanently or temporarily, revoke the consent to the processing of personal data, in whole or in part, by written request sent to the above address, in writing or by e-mail. The revocation of the consent does not affect the lawfulness of the processing that was carried out on the basis of the consent until its cancellation.

An individual has the right to file a complaint at the Information Commissioner of the Republic of Slovenia if he/she considers that his personal data are stored or otherwise processed contrary to the applicable regulations governing the protection of personal data.

## IV. Deadlines for storing personal data

BSL d.o.o. processes personal data to the extent necessary to achieve the purposes of the processing, as long as it is necessary to achieve the objective pursued.

Personal data is thus processed until the purpose is fulfilled or within the limits of the limitation periods for obligations that could arise from the processing of these personal data, especially when the processing of personal data is necessary in the context of the conclusion or implementation of the agreement or contract, except in cases where the deadline for preservation of personal data is prescribed by law. In the latter cases, the operator shall keep the data in accordance with the legislation. Where the processing of personal data is based on the consent, it shall cease to apply within a reasonable period of time which is necessary for the cancellation or anonymisation after receipt of the cancellation.
